#### **Background**

- FUTUREBR calls for the creation and adoption of small area plans as a vehicle to further refine the Vision of FUTUREBR throughout the City-Parish
- This planning initiative is part of a larger effort involving the City-Parish, Build Baton Rouge, and the Cortana Corridor Economic Development (CCEDD)
- Build Baton Rouge initiated development of the plan in 2023, hiring Perkins & Will as the lead consultant, to build upon:
  - o The success of the MOVEBR initiative that included improvements to Florida Boulevard
- Build Baton Rouge held multiple community events promoting development of the plan throughout 2023-2024
- This amendment will formally adopt the Florida Corridor Master Plan, providing a basis for redevelopment, revitalization, and continued implementation of prior initiative along the corridor



#### **Comprehensive Plan Consistency**


- Amendment is consistent with:

  - Land Use Action Item 4.2.1: Create a vision for redevelopment that is matched with achievable market conditions and promotes desired infill and redevelopment;
  - Land Use Action Item 5.1.3: Support development compatible with surrounding neighborhoods to promote choice in public transit;
  - Land Use Action Item 5.1.4: Direct public investment (libraries, community centers, schools, transit, parks, etc.) toward neighborhood identified as needing greater assistance;
  - Land Use Action Item 5.3.1: Invest in infrastructure upgrades that support development in area where change is anticipated;
  - Community Design and Neighborhoods Action Item 2.1.1: Encourage the building of environments that respect the character of place and support the uniqueness of an area; and,
  - Community Design and Neighborhoods Objective 2.2: Use the small area planning process to prioritize areas where change is desired.


